2. **Question:** Bidding Instructions, Page 7, Payment: Please further explain, "County will make partial payments for all purchases made under the contract/ purchase order accumulated during the month.

**Answer:** Monthly invoices shall be submitted in duplicate to the District Attorney- Business Office, 2220 Tulare St., 10<sup>th</sup> Floor, Fresno, CA 93721. This will be a reoccurring process over the life of the agreement. 3. **Question:** Participation, Page 11: Please confirm if extending same terms and conditions apply only if services are the same.

**Answer:** Yes, the services will be in accordance with the terms and conditions of the original contract.

4. **Question:** Scope of Work, Page 13, #1: Must services be located in the Fresno/Clovis metro area or only provided in the Fresno/Clovis metro area? Meaning we could store the records in Sac and provide deliveries in Fresno?

**Answer:** We do not believe that having the records outside of the Fresno/Clovis area would work as sometimes there is a need to have the files here on the same day as the request.

5. **Question:** Scope of Work, Page 13, #6: Can we do same day service for STATS? Are any weekend or holiday deliveries required/ expected?

**Answer:** Weekend and holiday deliveries would not be required/ expected.

6. **Question:** Quotation Schedule, Page 14, Group II Delivery Services: Define "Rush Delivery"? Will electronic delivery be acceptable for Rush Delivery and Same Day Delivery?

**Answer:** Rush delivery would mean asap same day delivery. Electronic delivery would not be acceptable as our files are hardcopies. We should not have the storage operator going through and scanning them for electronic delivery.
