

**FIRST AMENDMENT TO AGREEMENT**

THIS FIRST AMENDMENT TO AGREEMENT (hereinafter "Amendment") is made and entered into this 14<sup>th</sup> day of September, 2010, by and between COUNTY OF FRESNO, a Political Subdivision of the State of California, 2220 Tulare Street, Fresno, CA 93721 (hereinafter "COUNTY"), and SENTINEL OFFENDER SERVICES, LLC, a Delaware Limited Liability Company, whose principal California address is 220 Technology Drive, Suite 200, Irvine, California 92618 (hereinafter "CONTRACTOR").

**WITNESSETH:**

WHEREAS, COUNTY and CONTRACTOR entered into Agreement number A-05-443 on the 20th day of September, 2005 (hereinafter "Agreement"), pursuant to which CONTRACTOR agreed to operate an offender-paid, adult electronic monitoring program for probationers chosen by the Probation Department as suitable for participation in said electronic monitoring program; and

WHEREAS, the Agreement is now scheduled to expire on September 30, 2010; and

WHEREAS, COUNTY will be unable to complete the bid process for services before said date of expiration; and

WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement to extend its term an additional six (6) months.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

1. Section IV. of the Agreement, entitled "Term" is hereby amended so that lines 5 through 10 on page 8 are deleted in their entirety and replaced with the following:

"This Agreement shall become effective on October 1, 2005 and shall terminate on March 30, 2011."

1 COUNTY and CONTRACTOR agree that this Amendment is sufficient to amend the  
2 Agreement and, that upon execution of this Amendment, the Agreement and this Amendment  
3 together shall be considered the Agreement.

4 The Agreement, as hereby amended, is ratified and continued. All provisions, terms,  
5 covenants, conditions and promises contained in the Agreement and not amended herein  
6 shall remain in full force and effect.




