REQUEST(S): That the Board receives the listing of potential clients for the SJVIA

DESCRIPTION:

At the direction of your Board, Gallagher Benefit Services has conducted a survey of potential clients for inclusion on the SJVIA. (Please see attached survey)

GBS first identified a geographical area for survey that spanned from Kern County in the south to San Joaquin County in the north as well as the Sierra Nevada mountains to the Central Coast. Specifically targeted were County and City entities. The data received and compiled in the attached survey was the result of personal telephonic conversations with each entity as well as additional information available to GBS as a result of their involvement with several associations related to the public sector (CalPELRA, etc).

Separate and apart from this survey, GBS has been contacted by several public entities requesting information on the SJVIA. Additionally, GBS is currently responding to a Request for Proposal for the County of Nevada for Consultant services. Though not specifically targeted in this survey, the County of Nevada would fit the criteria for consideration by the SJVIA due to its size, probable demographics and location.

Concurrently with this survey of SJVIA expansion potential, GBS has engaged their actuarial division, Gallagher Analytics, to develop pricing modules for entities of various sizes. Specifically, GBS has produced a rating methodology that would establish a "manual rate" based on the pooled experience of the SJVIA. Individual, group-specific demographics could then be applied (age/gender, experience, average contract size, account location, etc) to create variance factors to apply to these manual rates. The resulting premium rates would be based on accepted underwriting standards and practices and reflect the overall experience of the entire SJVIA pool while allowing individual group demographics to impact final rates.
