**<u>REQUEST(S)</u>**: That the Board Adopts the Revised Fiscal Year Budget

#### **DESCRIPTION**:

On July 22, 2011, your Board approved the budget for the fiscal year of July 1, 2011 through June 30, 2012 with the intent of updating the budget with the approved rates for the plan year beginning January 1, 2012 at a later meeting. It should be noted that in addition to incorporating the approved rates for plan year 2012, the revised budget assumes reduced enrollment based on current SJVIA trends and the separation of Fresno Superior Court employees from the County of Fresno health pool. Agenda item 6(d) on today's agenda provides additional information on changes in SJVIA enrollment. Enrollment for the recommended 11-12 budget is assumed at 8417 for the July 1, 2011 through December 31, 2011 and at 7772 for January 1, 2012 through June 30, 2012. By way of comparison, the 10-11 budget assumed enrollment of 10,094 participants for the entire 12 month period. The total combined expenses and reserves in the recommended budget is \$60,528,931 (compared to \$66,371,807 in the FY 10-11 budget).

The expense categories that are summarized on Exhibit A include both claims and fixed expenses. Fixed expenses include:
