REQUEST(S): That the Board Receive and File the Report the SJVIA RFP for Health

Administrative Services

DESCRIPTION:

The Manager and Assistant Manager of San Joaquin Valley Insurance Authority (SJVIA) have instructed Gallagher Benefit Services (GBS) to conduct a Request for Proposal (RFP) for Administration Services Only (ASO) and Third Party Administration (TPA) bids for the group medical PPO portion of the SJVIA plan. The RFP will anticipate a January 1, 2013 potential effective date. GBS is also requesting HMO Minimum Premium bids or other alternate funding options for the HMO portion of the SJVIA pan, with a potential effective date of December 10, 2012. For a TPA, GBS is also requesting a provider network access bid, as part of the TPA proposal. These proposals will compete for the business currently with Anthem Blue Cross, the SJVIA primary carrier.

An additional request made within the RFP will be for a <u>Second Carrier Option</u>. The current plan is administered by Anthem Blue Cross; however, the SJVIA RFP is also requesting proposals for a "second" carrier to work alongside Anthem as an alternative choice within SJVIA, presuming Anthem is retained. SJVIA will select a second carrier to offer plans to new members wanting to join the SJVIA who are currently contracted with Anthem and may be precluded from entering SJVIA because of Anthem's "Blue on Blue" bid restriction. Potential business for the second carrier may be effective as early as July 1, 2012. A request has been made that they provide HMO and PPO Administrative Services Only rates assuming the same demographics of the in force business.
