#### DESCRIPTION:

Gallagher Benefit Services (GBS) has been compiling and delivering the attached Monthly Claims Report to SJVIA staff. The reports are delivered on the last Friday of each month and reflect claims data through the end of the previous month. The report provides a high level view of several key claims metrics and is useful in the early identification of potential trends and outliers. The Monthly Claims Report is meant to augment the quarterly (and annual) claims report and opportunity analysis developed by Anthem Blue Cross.

As requested by your board, a Large Claim Report has been included in the Monthly Claim Report (page 3). This summary details claims that have reached 50% of the pooling point (\$250,000) for the HMO plan as well as claims that have reached 50% of the stop loss deductible (\$450,000) for the PPO plans.

Of particular note in the attached report (January 2011 to November 2011):

- Executive Summary (page 2)
  - Enrollment has dropped 3% during the review period
  - Surplus has increased \$1,230,514 during the review period
  - Fixed costs remain under 10% of total costs (9.43%)
- Page 10
  - Monthly claims (year over year) show similar trends in corresponding months
