### **DESCRIPTION**:

At the October 7, 2011 meeting, your Board approved a contract with Delta TeamCare to perform wellness evaluations and provide other services to heighten SJVIA health plan participants' aware of the importance of healthy living. The results in the aggregate reporting of the evaluations that took place earlier in the year show that there is significant opportunity for SJVIA to promote preventive care and healthy and more active lifestyles.

The Anthem Blue Cross 360 Health Program and the Delta TeamCare Wellness plan have many options for the members of the SJVIA, and entities can choose to offer activities as many or as few as desired. Both Counties have reviewed the reporting results both for the SJVIA and for their respective population along with the offerings from both vendors and have developed a calendar of activities that would benefit their employees.

Wellness centered activities, whether a walking program with pedometers, or a seminar taught by a health professional, have shown to impact not only employee health, but also morale and attendance. A walking program is the first activity that will be kicked off in the near future. As part of the program, participants will be given a pedometer supplied by Anthem Blue Cross and Delta TeamCare. Staff from both counties had developed a calendar to include the following topics of interest:

- Diabetes Awareness
- Smoking Cessation and COPD
