SUBJECT: Approve Revised 2014-15 Fiscal Year Budget (A)

REQUEST(S): That the Board approve the revised budget for the

2014-15 fiscal year

DESCRIPTION:

On August 22, 2014 your Board approved the budget for the 2014-15 fiscal year commencing July 1, 2014. Since then, stop loss rates were finalized slightly higher than projected, several entities joined the SJVIA, and open enrollment changes for the 2015 plan year have been finalized. Specific changes to the proposed revised 2014-15 budget include:

- 2015 stop loss rates (previously approved):
 - o Specific from \$14.21 to \$14.86 per employee per month
 - o Aggregate \$.94 to \$.91per employee per month
- Updated eligibility effective January 1, 2015
 - o The overall number of employees included in the budget increased from 9,745 to 11,749.
 - o HMO enrollment decreased by 0.8%
 - o PPO enrollment increased 17.7%
 - o Kaiser enrollment increased by 244%
- Addition of the following groups to the SJVIA
 - 1. City of Clovis (January 1) 395 employees
 - 2. City of Modesto (January 1) 978 employees

- 3. City of Hughson (January 1) 15 employees
- 4. City of Oakdale (January 1) 69 employees
- 5. City of Hanford (January 1) 194 employees

FISCAL IMPACT/FINANCING:

This budget revises the revenue to \$112,599,711 and expenses to \$115,764,322 for the 2014-15 fiscal year.

Consistent with the Board's prior direction at the August 22, 2014 SJVIA Board Meeting, the revised budget reflects the use of reserves in the amount of \$3.16 million to mitigate a portion of the premium increase in the 2015 plan year.
