

RESOLUTION NO. 2016- 60R

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SELMA ORDERING THE SUBMISSION OF A GENERAL OBLIGATION BOND AND PROPOSITION TO THE QUALIFIED VOTERS OF THE CITY OF SELMA AT THE GENERAL ELECTION TO BE HELD ON NOVEMBER 8, 2016, FOR THE PURPOSE OF THE ACQUISITION AND CONSTRUCTION OF LOCAL POLICE STATION AND ASSOCIATED IMPROVEMENTS AND REQUESTING THAT THE BOARD OF SUPERVISORS CONSOLIDATE THAT ELECTION WITH A STATE-WIDE ELECTION HELD ON THE SAME DATE

WHEREAS, on July 5, 2016, by a two-thirds vote of its entire membership, the City did determine by Resolution No.2016-51R, that the public interest and necessity demand the acquisition and construction and completion of municipal improvements consisting of the acquisition and construction of a Police Station and Associated Improvements (the "Police Station Improvements") and that the Police Station Improvements are necessary and convenient to carry out the objects, purposes and powers of the City and that the cost thereof will require expenditure greater than an amount allowed for by the annual tax levy of the City and that it is the intention of the City to issue bonds to finance the cost thereof; and

WHEREAS, on August 1, 2016, the City Council of the City of Selma by a twothirds vote of all of its members adopted Ordinance No. 16-4, an Ordinance of the City Council of the City of Selma Ordering the Submission of a General Obligation Bond Proposition to the Qualified Voters of the City of Selma at the General Election to be held on November 8, 2016, for the Purpose of the Acquisition and Construction of a Local Police Station and Associated Improvements; and

WHEREAS, the City Council of the City of Selma desires, and by this Resolution, does clarify its request of the County Clerk/Registrar of Voters in connection with its Ordinance No. 16-4 placing the foregoing measure on the November 8, 2016, ballot.

NOW, THEREFORE, the City Council of the City of Selma hereby resolves as follows:

- 1. That the foregoing facts are true and correct.
- 2. The intended purpose of this resolution is to supplement and clarify Resolution 2016-51R, and Ordinance 16-4, and not to supplant or supersede said Ordinance and Resolution.

- 3. The City of Selma hereby requests that the Fresno County Clerk/Registrar of Voters conduct the election and that the measure in Ordinance 16-4, be voted on and consolidated with the state-wide election to be held on November 8, 2016 and requests the Fresno County Board of Supervisors that the election for this measure be consolidated with said state-wide election.
- 4. The question to be submitted to the voters with respect to the ballot measure shall be printed on the election ballot with the title and in the form set forth as follows:

5. The following constitutes the synopsis of the measure to be voted on for purposes of meeting the publication requirements of Election Code §12111.

MEASURE TO BE VOTED ON

NOTICE IS HEREBY GIVEN that the following measure is to be voted on at a general municipal election to be held in the City of Selma on Tuesday, the 8th Day of November, 2016. The measure to be voted on is one to authorize the City to issue \$4,000,000 in bonds, at legal rates, requiring an average debt service of \$230,000 annually, for thirty (30) years, by assessing \$16 per \$100,000 of assessed value and requiring financial audits, citizen oversight and the funds to be spent on the acquisition, construction and improvements of a Police Station in the City of Selma.

The measure to be voted on would authorize the issuance of the \$4,000,000 in bonds, having a maximum rate of interest to be paid on the bonds at 6% per annum, to finance a portion of the total cost of construction acquisition and completion of a Police Station and associated improvements and an assessment against all taxable real property in the City to fund the annual debt service.

- 6. The full text of the Ordinance of the City Council of the City of Selma ordering the submission of a general obligation bond proposition to the qualified voters of the City of Selma at the general election to be held on November 8, 2016 for the purpose of the acquisition and construction of a local Police Station and Associated Improvements, Ordinance 16-4, is attached as Exhibit A. The full text of the Ordinance is not required to be printed in the sample ballot and voter's pamphlet. However, the full text of the Ordinance shall be made available at the office of the Fresno County Clerk/Register of Voters and the Selma City Clerk's Office.
 - 7. Passage of this measure requires a two-thirds majority of votes.
- 8. The City of Selma requests the Fresno County Clerk/Registrar of Voters conduct the election and canvas the returns, and the City consents to reimburse the Registrar of Voters for all costs being incurred by said services.
- 9. In all particulars not recited in this Resolution, the election shall be held and conducted as provided by law for holding municipal elections.
- 10. Arguments in favor of or against the proposed measure are permissible and shall be filed with the Fresno County Clerk/Registrar of Voters in accordance with Election Code §3282. The Mayor and Mayor Pro Temp of the City of Selma are authorized to cause to have prepared and filed a written argument in favor of the proposed measure not to exceed 300 words on behalf of the City Council. The Mayor and Mayor Pro Temp are further authorized to provide input to the Fresno County Clerk/Registrar of Voters in determining a new letter designation for this measure, if Measure "P" is not available. In the event that an argument is filed against the measure, the Mayor and Mayor Pro Temp of the City of Selma is authorized to cause to be prepared and to file a rebuttal argument on behalf of the City Council.

- 11. The Fresno County Clerk/Registrar of Voters shall give the appropriate notices for the election and shall conduct the election pursuant to the appropriate provisions of State Law. The City of Selma acknowledges that the Fresno County Clerk/Registrar of Voters may conduct the election in accordance with Elections Code §10418.
- 12. The City Attorney shall prepare an Impartial Analysis of the measure in accordance with Elections Code §3280 and shall file it with the Fresno County Clerk/Register of Voters.
- 13. The City Clerk shall cause a certified copy of this Resolution, Ordinance 16-4, and Resolution 2016-51R with the Fresno County Clerk/Registrar of Voters as required by applicable law. The City Clerk is authorized and directed to work with the Fresno County Clerk/Register of Voters and to take all steps necessary to cause placement of the measure on the ballot.
- 14. The City Clerk and City Attorney are authorized to make any typographical, clerical, non-substantive corrections to this Resolution as may be deemed necessary by the Fresno County Clerk/Register of Voters.
