CALLING AN ELECTION TO AMEND
FRESNO COUNTY CHARTER
SECTION 21

RESOLUTION NO. 16-295

WHEREAS, California Government Code sections 23720(a) and 23722 permit a county board of supervisors to propose amendment to the county charter and to submit the amendment to the eligible registered voters of the county at a special election held on the next established election date not less than eight-eight (88) days after submission of the proposal; and

WHEREAS, the Fresno County Board of Supervisors proposes to amend Section 21 of the Charter of the County of Fresno to provide that the Chief Probation Officer of the County of Fresno shall be appointed by, and serve at the pleasure of, the County Administrative Officer rather than the judges of the Superior Court of the County of Fresno.

NOW THEREFORE, be it resolved:

1. Pursuant to California Elections Code section 10403, the Board of Supervisors hereby directs a charter amendment measure be placed on the ballot for the November 8, 2016 general election and be consolidated with that election.

2. The Fresno County Clerk/Registrar of Voters is designated as the elections official for the election, and the Fresno County Clerk/Registrar of Voters is hereby authorized and directed to provide all notices and take all other actions necessary to holding the election, including but not limited to providing notices of times within which arguments for and against are submitted.

3. The ballot measure hereby approved for said election shall be as follows:



1 EXHIBIT A

2 SECTION 21. The Probation Officer shall be appointed by and serve at the pleasure
3 of the Judges of the Superior Court County Administrative Officer with prior
4 approval of the Board of Supervisors of the County of Fresno with consultation of
5 the Judges of the Superior Court. The salary of the Probation Officer and of deputy
6 probation officers shall be fixed by the Board of Supervisors. In all other probation
7 matters the General Law shall apply and the Probation Officer shall be governed
8 thereby. This section shall apply to any incumbent Probation Officer in office on
9 the effective date of this section and any subsequent Probation Officer
10 appointed after the effective date of this section.
