## From the Retirement Administrator: The Year in Review



It's a good time to reflect on what we accomplished during calendar year 2009. The year was rewarding and challenging for the Board and FCERA Administration, full of investment opportunities, given the current financial environment and federal stimulus monies, and very challenging from the operational side, given the

current economic and budget climate.

We are glad to report that we accomplished most of our goals for the year, even as our core operations were stretched thin by a dramatic budget climate for the plan sponsors. Among the most noteworthy projects or events that FCERA worked on and/or completed were the following:

- Completed two of the five business initiatives in the Strategic and Business Planning document: the Internal Investment Position feasibility project and the Information Technology Roadmap/Assessment project.
- Made substantial progress on the General Ledger Accounting Software initiative, which is currently in the contract negotiation stage with implementation scheduled for completion by June 30, 2010.
- Revised the Asset Allocation approved in August 2008 and initiated the implementation process with 13 new investment accounts totaling \$752 million.
- Enhanced access to Board meetings through the implementation of an audio archive to listen to the Board discussions and presentations at your leisure from your own computer.
- Received our 12th consecutive Certificate of Achievement for Excellence in Financial Reporting for the Comprehensive Annual Financial Report (CAFR).
- Earned an unqualified "clean" opinion from our external auditors for the June 30, 2009 financial audit.
- Issued over 63,000 monthly benefit payments totaling \$162,927,183.
- Completed 1,214 counseling sessions; 189 disposition requests; 148 retirement estimates; 346 service credit calculations; and retired 337 members.
- Issued the first handbook dedicated to our retired members.

During 2010, the Board of Retirement and FCERA Administration will continue working diligently on understanding the dynamic changes in the financial markets and finalize implementation of the revised asset allocation which is expected to increase investment returns while decreasing expected volatility.

We will also continue our efforts to become more efficient by streamlining our processes and providing a higher quality of customer service to our members. To that end, FCERA is in the process of reorganizing and adding staff including an Supervising Account Clerk and Retirement Coordinator Supervisor.



## 2009 COLA for Implementation in April 2010:

Our preliminary calculation of the Cost-of-Living Adjustment (COLA) for calendar year 2009 as determined by the annual average Consumer Price Index for the Western Region of the United States suggests a -0.5% COLA. Please note this issue will be discussed at the Board of Retirement meeting on Wednesday, February 17th. We encourage you to attend the meeting or forward your comments to the Board prior to the meeting in the event you are unable to attend.

### **Stakeholder Relations Program:**

FCERA's strategic plan, adopted in June 2008, requires the establishment of a stakeholder relations program intended to improve its communications, dealings and interactions with all stakeholders for more productive and efficient relationships. ### Tax Updates:

Form 1099R Mailings for Tax Year 2009 - Form 1099R will be mailed to current retirees and terminated members who received a refund of contributions during the 2009 tax year. State Street Bank will mail the Form 1099R by February 1, 2010. If you do not receive it by February 10, 2010, please contact the FCERA office at (559) 457-0681 to request a duplicate. Duplicate 1099R forms will be mailed to the address on file. If you have recently moved and have not updated your permanent address with FCERA, you will need to submit a change of address form before a duplicate Form 1099R can be mailed. A change of address form can be requested by calling our office or by printing the form from our website, <a href="https://www.fcera.org">www.fcera.org</a>.

Tax withholding changes in 2010 for Retirees - Effective with your January 29, 2010 retirement benefit payment, the federal and state income tax withholding tables have been updated to reflect the new 2010 tax rates. If you currently have federal and/or state income tax withheld from your retirement benefit payment, you may notice a change in tax withholding. If you would like to change your current withholding elections, you can obtain the federal withholding form W4-P and state withholding form DE-4P for tax year 2010 on the FCERA website at <a href="www.fcera.org">www.fcera.org</a>. Just click on Forms, Regulations, Charters and Policies on the left side of the home page, then click All Forms.
