17 WHEREAS, this Board has been advised that said qualification
18 is not automatic, and will require from thirty to sixty
19 days to obtain;

20 NOW, THEREFORE, be it resolved that the said resolution of
21 April 22, 1963, consenting to the inclusion of the North Central
22 Fire Protection District into the Fresno County Employees Retirement
23 Association be and it is hereby amended to become effective on
24 the 1st day of the month next succeeding the month in which the
25 members of the North Central Fire Protection District become
26 qualified for Social Security benefits.
