Dear Mr. Brock:

At your request we have assembled a small supplement to the regular Actuarial Report of the Employees' Retirement Association of the County of Fresno made to the Board of Retirement as of October 31, 1974.

The contribution rates provided in this letter assume the Safety Member Provisions under Section 31639.5 as well as the Miscellaneous Members under Section 31621.5. The final average salary basis has been assumed to be one year.

It should be noted that the Members' cost of living contributions are equivalent to 37.98% of the total revised employee normal contributions as indicated in this letter. This percentage applied to the revised employee normal rates results in the same amount of employee cost of living contributions as shown in our report since we were informed that the County intends to make the same cost of living payments as indicated in that report.

The County Cost of Living Contribution Rate is at a level such that it will exactly match the cost of living contributions made by the Members. This assumes a maximum change in the cost of living benefit of 3% per year.

For the County's basic contribution rate we recommend the following:

The funding is to be provided under Section 31453.5 (better known as AB777).

Based on the County's present contribution rates, the corresponding figures would be \$1,143,155 and \$4,015,354 for the Safety and Miscellaneous members respectively, producing a total County annual contribution of \$5,158,509.

In our opinion, with the adoption by the County of recommendations made above, the System will continue to be maintained on a sound actuarial basis, in accordance with the provisions of the 1937 County Law.
