Dear FCERA Members:

I have attached correspondence about the new employee retirement contribution rates that will become effective with the pay period beginning July 2, 2006, for the pay date July 28, 2006 for County employees and the first pay period of July for Special Districts. The new rates call for an average rate increase of about 16.5% for general members and about 8% for safety members. However, the actual increase will depend on the member's entry age of membership with FCERA. Please note the average increases are a percentage of the contribution amount you are already contributing, NOT a percentage of your total pay.

I respectfully request that the County Departments and Special Districts help us in making sure that all FCERA members receive this information by displaying a copy of the letter on your employee bulletin boards or by giving a copy of the letter to those employees who do not have access to County e-mail.
