BOARD OF RETIREMENT GENERAL, RETIRED AND ALTERNATE RETIRED MEMBER ELECTIONS

1. The TERM OF OFFICE is 3 years, commencing January 1, 2014 and terminating December 31, 2016.
2. Regular meetings are held on the FIRST AND THIRD WEDNESDAYS of each month at 8:30 a.m., Fresno County Employees' Retirement Association, Board Room, 1111 H Street, Fresno.
3. QUALIFICATIONS:
 - a) RETIRED MEMBER - Candidate must BE A RETIRED (not an Active, Deferred or Inactive Safety or General Member) of the Fresno County Employees' Retirement Association.
 - b) ALTERNATE RETIRED MEMBER - Candidate must BE A RETIRED MEMBER (not an Active, Deferred or Inactive Safety or General Member) of the Fresno County Employees' Retirement Association.

4. PROCEDURES:
 - a) Nomination – PETITION FOR NOMINATION can be obtained from the Fresno County Employees' Retirement Association, 1111 H Street, Fresno or the internet website at www.fcera.org.

The petition shall include nominee name, certification of willingness to serve, and signature of fifteen (15) Retired Members. Please note that one individual may not sponsor more than one individual for each vacant position.

The nominee may submit a STATEMENT OF QUALIFICATIONS AND PLATFORM not to exceed two hundred (200) words, which will be part of the ballot packet. The statement should be in an electronic format and can be e-mailed to eavalos@co.fresno.ca.us or submitted on a disk. The statement will be printed exactly as submitted, subject to the word limit and is due at the same time as the Nomination/Declaration of Candidacy.

- b) Thursday
September 12, 2013 – First day to file NOMINATION and STATEMENT.
- c) Wednesday, 5:00 p.m.
October 2, 2013 – Last day to file NOMINATION and STATEMENT.
- d) Thursday
October 31, 2013 – Ballot packet will be mailed to each eligible voter at his or her place of residence as on file with the Retirement Office.
- e) Thursday
November 21, 2013 – Date of election.

Ballots are to be returned to the Elections Department either by U.S. Postal Service, County messenger mail or in person by 5:00 p.m. Eligible members residing in foreign countries may contact the Fresno County Clerk/Registrar of Voters at (559) 600-8683 for alternate means of voting.

- f) Friday, 8:00 a.m.
November 22, 2013 - Election Manager shall count the ballots and certify the results.
