Health Insurance Open Enrollment Plan Year 2017



Fall is a short but sweet season in Fresno. Some days may still get hot, but we can enjoy the cool breeze of the mornings and evenings while looking forward to the promise of rain. Fall also brings our season of open enrollment for current employees and retirees for 2017 health, dental, and vision plans. As in years past, former County of Fresno employees will have County Health Insurance options. Retired Employees of Fresno County (REFCO) members will have many different insurance options to choose from. Additionally, all retired FCERA members will have the option to purchase CIGNA Dental and VSP Vision Care insurance through FCERA's membership with the State Association of County Retirement Systems (SACRS). Payroll deductions are now available for county health plans and payment of insurance premiums through REFCO and SACRS. Retirees will be sent information in the mail regarding their options. FCERA staff is not involved with the open enrollment process or able to offer advice regarding your options, so we encourage you to carefully review your options to choose the plan best suited for your situation.

Information from County of Fresno Human Resources:

Open Enrollment for Plan Year 2017 is scheduled to begin **Monday, October 24, 2016** and will continue through **Thursday, November 10, 2016**, with changes taking effect **January 1, 2017**. Open Enrollment is the one time during the year that retirees may enroll in one of the County's health insurance plans or make changes to the plans in which they are currently enrolled, including adding dependents without a qualifying event. If you do not wish to enroll or make any changes to the health insurance plans you are currently enrolled in, no action is required on your part. However, we encourage you to attend one of the events listed on page 2 to help you make an informed decision regarding what is best for you and your family.

The 2017 county health plan rates were not finalized at the time of printing; the item recommending these rates was scheduled for the Fresno County Board of Supervisors meeting on October 11, 2016 and was continued to the meeting on October 18, 2016.

- **9/20/16**—mailed to employees of Fresno-Madera Area Agency on Aging, Clovis Veterans Memorial District, and Fresno Mosquito and Vector Control District
- **10/5/16**—mailed to employees of Fresno Superior Courts
- **10/12/16**—mailed to deferred members
- **10/17/16**—mailed to retirees and beneficiaries
- **10/21/16**—mailed to employees of the County of Fresno
