#### ADDENDUM NO. ONE (1) REQUEST FOR QUOTATION NUMBER 285-5220 October 22, 2013

Q. I am trying to prepare my bid package but I have a question in regards to the "prevailing wage" portion of the specs. The specs direct me to a website which only assists me (the bidder) in determining what prevailing wages are for this specific scope of work. Our opinion is that it should be up to the County to determine where our technicians fall in regards to wages and benefits. We could make a determination of where we think they fall only to find out that this is not matching County workers in similar job responsibilities.
