The County is adding the following item to the RFP as an "emergency/extra repair." This item will <u>not</u> be part of the annual preventative maintenance and, therefore, shall not be included as part of the preventative maintenance bid. Repair services shall be provided for:

Lighting Control & Design (LC&D) GR 2400 Lighting Control Panels

Detention Housing: 12 Panels
Commitment Housing: 10 Panels

These Lighting Control Panels will be subject to the "Critical Malfunction" response requirements as shown in the Scope of Work on Page 21, Item 5, and shall be added to the list of equipment covered under "critical malfunctions" as Item 6. I. Lighting Control Panels on page 22.

In light of the removal of the locks from the RFP (see Q&A3. below), as well as the addition of the Lighting Control Panels, Item 1 of the Cost Proposal Section on Page 32 of the RFP is deleted in its entirety and replaced with:
