## **QUESTIONS & ANSWERS**

- Q1. Are prices to remain fixed for the entire three year term?
- A1. Yes, Prices are to remain firm for the entire three year term. Please state exception in your bid if you cannot hold prices for the entire three year term.
- Q2. Page 5 Merchandise Returnable for Full Credit We will not accept returns of items in "good condition". Only new, unopened items will be accepted for return within 15 days of delivery.

  Most items on this contract are ammunition or safety equipment, once opened and/or used, we cannot resell it.
- A2. This addendum will change the section on Page 5 <u>Merchandise Returnable for Full Credit</u> of the original RFQ #680-5415 to read as follows:
  - **MERCHANDISE RETURNABLE FOR FULL CREDIT:** Bidder agrees to accept for full credit any merchandise sold by him on contract or award resulting from this bid, if returned in new and unopened condition within 15 days.
- Q3. Page 5 Guarantee Against Defects our manufacturers have a warranty against defects, not a guarantee. Therefore we cannot offer a guarantee. Will a warranty suffice?
- A3. Yes, a warranty will suffice. This addendum will change the section on Page 5 **Guarantee Against Defects** of the original RFQ #680-5415 to read as follows:
  - **WARRANTY AGAINST DEFECTS:** All items are to carry a full warranty against defects in materials and workmanship and warranty against breakage and other malfunctions when performing work for which they are designed.
- Q4. Page 8 Insurance This is a contract for goods, not services or construction. Is the insurance still required? Delivery will be made by common carrier, not company owned vehicles.
- A4. At this this time, the automobile insurance is not required since delivery is made by common carrier.
- Q5. Page 10 Guaranteed Pick Up and/or Delivery Neither manufacturer (Federal Cartridge or Simunition) will guarantee a delivery date for their items. Therefore it is not possible for a distributor to guarantee a delivery date. This is especially true for live ammunition as demand has surged in recent years. We can provide and estimated delivery range based on current conditions, but it will change over the course of three years.
- A5. Yes, for Guaranteed Pick Up and/or Delivery, please provide us with your best estimated delivery range based on the current conditions. Should a natural disaster or unforeseen changes should occur, vendor will make every attempt possible to insure delivery is within specified best estimated delivery time.
- Q6. Last, can freight charges be added? On the previous contract for Simunition this was allowed due to the variety of items that could be ordered. The same would apply now, especially for the protective gear since there is no way to determine freight charges without knowing a quantity to be ordered.
- A6. Yes, freight charges can be added. Shipping term is FOB Destination.
