## QUESTIONS AND ANSWERS

**Q1. The State of California requires money services companies to have a valid California Money Transmitter's License. The RFP issued by the County does not require a Money Transmitter's License. Please confirm the prime contractor must have a current money transmitter's license in the State of California.**

*A1. Yes, the prime contractor for this RFP must have a current money transmitter's license in the State of California.*

**Q2. What is the anticipated decision date?**

*A2. The County does not have an anticipated or set decision date. After the bid closing, an evaluation team will meet to rate the proposals approximately 2-3 weeks later. The evaluation team will then submit their recommendation to the department head, who will then submit a letter of recommendation to the Purchasing Department. Purchasing will then release a tentative award notice the same day the letter of recommendation is received.*

**Q3. When can we expect responses to questions?**

*A3. All responses to questions will be answered in this addendum.*

**Q4. Can you tell me if there is compensation from the current cash/lobby kiosk system that accrues to the County? If so, can you provide the percentages based on each type of transaction?**

*A4. No, there currently is no compensation from the current cash/lobby kiosk to the County.*

**Q5. Please clarify Item "I" of Section #2 on page #23, regarding the two traceable receipts.**

*A5. A minimum of two (2) traceable receipts for all transactions shall be provided in the Booking Intake Kiosk and shall include the date, time, inmate's name, Jail Identification number, and money amount, at a minimum, on the receipt. The Lobby Kiosk shall have a minimum of one (1) traceable receipt for all transactions and shall include the date, time, inmate's name, Jail Identification number, and money amount, at a minimum, on the receipt.*
