**Questions from the April 13, 2016 Vendor Conference and County response.**

1. **Question:** The specifications appear to be written to reflect a Mettler-Toledo scale. Will you consider other makes/models- specifically, ones that do not use load cells?

**Answer:** The County will only consider scales that employ load cell technology.

2. **Question:** When a truck with an RF tag enters the scale how is the information conveyed to the Scalehouse software? What modem carries the information?

**Answer:** The information is transmitted from the scale to a reader through an RS-232 connection.

3. **Question:** What contractor's license is required for the project?

**Answer:** Class A.

4. **Question:** Is there a Site Plan available?

**Answer:** The County can make available a plan depicting the scale area.

5. **Question:** Will the existing pit have to be excavated or can it just be filled in?

**Answer:** The foundation requirements are detailed in the RFQ.

6. **Question:** Will the height of the kiosk that dispenses the ticket have to be adjusted?

**Answer:** That would depend on the scale dimensions. It would stand to reason that since the scale will be above ground, the kiosk would need to be adjusted higher.

7. **Question:** Since this will be an above-ground scale will rub rails need to be installed?

**Answer:** Yes. Include them in the cost of the scale.

8. **Question:** Is there any other electrical service to the pit other than the electrical service to the scale? If so, who will handle that?

**Answer:** There is electrical service to the printer that dispenses the tickets just outside the pit. It shall be the bidder's responsibility to disconnect and restore any electrical service that is disturbed.
