QUESTIONS AND ANSWERS

Q1. Are there any plans?

A1. *The plans vary depending on each site location.*

Q2. CSA- Does this require prevailing wage rates?

A2. *No, the CSA work will not require prevailing wage.*

Q3. Is there a 90-day clause to opt out of the contract?

A3. *There are typically termination clause(s) in County agreements; however, that would be discussed during the contract period with the awarded bidder.*

Q4. How far west does the County go?

A4. *From as far west as El Porvenir located near Interstate 5.*

Q5. How does the County address things (miscellaneous equipment) that don't fall under the scope of work, but would be required to do the job?

A5. *Bidder can add to the cost proposal.*

Q6. Are all the pumps shallow or deep well?

A6. *The deepest wells we currently have are around 800-900 feet deep. However in the near future it is planned that there will be four deeper wells (around 1600 feet) in the west side of the County for CSA 30 (El Porvenir) and CSA 32 (Cantua Creek).*

Q7. What is the deepest pump now?

A7. *About 700-800 feet.*

Q8. How deep is Shaver Springs?

A8. *About 900 feet.*

Q9. About how many pumps are potable?

A9. *.All well pumps are potable but we do have sewer pumps also, which are not potable.*

Q10. Do you have sewage pumps?

A10. *Yes, we have several sewage pumps.*

Q11. Are bonds required?

A11. *Bonds are not required at this time.*

Q12. Are you still 'doing' paper checks and 45-day pay?

A12. *Yes, the County has a net 45-day pay period.*

Q13. Is there a map available?

A13. *The maps are available and included in the RFQ.*

Q14. Is all work confined to Fresno County area?

A14. *Yes.*

Q15. If we have a different contractor's license, can we still bid on this project?

A15. As explained on page 11 of the RFQ:

The bidder shall possess a current State of California contractor's License, Class C-61 / D-21 or another license class that covers the work to be performed. The proposal must indicate the license held by the bidder, which enables him/her to perform the work.

Q16. Can we have the sign in sheet from the Vendor Conference?

A16. Yes, the sign in sheets are attached.
