OVERVIEW / TERM AND KEY DATES

PROGRAM OVERVIEW

The County of Fresno is soliciting proposals on behalf of the Department of Children and Family Services (DCFS), from eligible, qualified and experienced organizations and agencies to utilize Promoting Safe and Stable Families (PSSF) funds to administer family preservation and support services to at-risk families residing in the Laton community through the Laton Neighborhood Resource Center (NRC).

Eligible recipients of funds are limited to community-based organizations that possess an Internal Revenue Service Classification as a Non-Profit Organization (exempt status under Section 501(c)(3)) at the time of proposal submission and have the capacity to manage the existing NRC.

The maximum amount of PSSF funds proposers can apply for to administer the Laton NRC is \$210,000 for 18 month contract. (Funding \$140.000 Per Year)

PROPOSED TERM

It is County's intent to contract with the successful bidder for a term of (18) eighteen months. (\$210.000) County will retain the right to terminate the Agreement upon giving thirty (30) days advance written notification to the Contractor.
