QUESTIONS AND ANSWERS

- Q1. If the contract is for 3 years with a possible 2 year extension, should we provide budgets for 3 years?
- A1. Please provide budgets for the 5-year term.
- Q2. Regarding minimum duration and intensity, group sessions must include 2 to 12 sessions per week?
- A2. 2 to 12 refers to the size of group sessions per counselor. There must be a minimum of 20 hours of substance use disorder-focused face-to-face individual and group activity for each participant from Mondays through Fridays and a minimum of 6 hours of face-to-face individual and group activity scheduled on Saturdays and/or Sundays.
- Q3. Are outcomes addressed?
- A3. Yes, outcomes will be measured at intake, discharge, and post-treatment (one-year follow-up) and will include abstinence from substance use, criminal involvement, employment status, Child Protective Services involvement, social support, and treatment of co-occurring disorders.
- Q4. Under Key Staffing, it says that a Bachelor's degree is required for program director and clinical supervisor positions. Will this be standard?
- A4. Yes, this has been a requirement for a while. Any deviation would require County input and approval before an individual could provide services in either capacity.
- Q5. The annual funding amount may cause a reduction in bed days from previous years, would this be acceptable?
- A5. The number of bed days in your response should be realistic. We would like an accurate picture of costs so please be realistic in your estimate.
