QUESTIONS AND ANSWERS

Q1. Is there a possibility to provide an hourly rate and number of hours rather than it being based on the number of staff?

A1. Bidders are requested to use the Full-Time Equivalent (FTE) column and provide a percentage for each position based on an annual work schedule of 2,080 hours. Bidders are also asked to provide a breakdown of benefits. The budget form is being provided electronically so as to allow bidders to use this form.

Q2. Is there a page limit for the narrative response?

A2. There is no limit to the narrative response, however, bidders are asked to provide a concise narrative that encompasses the RFP.

Q3. What is the number of AOD prevention providers currently under contract?

A3. We currently have four (4) Substance Use Disorder prevention providers under contract until June 30, 2016.
