## FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT (hereinafter "Amendment") is made and entered into this 20<sup>th</sup> day of February, 2009, by and between COUNTY OF FRESNO, a Political Subdivision of the State of California, Fresno, California (hereinafter "COUNTY"), and the Law Firm of Campagne & Campagne whose address is 1685 N. Helm Avenue, Fresno, CA 93727, hereinafter referred to as "CONTRACTOR".

## WITNESSETH:

WHEREAS, COUNTY and CONTRACTOR entered into Agreement number 270173F, dated 29th day of March, 2007 (hereinafter "Agreement"), pursuant to which CONTRACTOR agreed to provide legal services for the Civil Service Commission to COUNTY; and

WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement in order to extend the term of the agreement for one (1) additional year.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

1. Section three (3) of the Agreement, located on page three (3), lines five (5) through nine (9), is deleted in its entirety and replaced with the following:

"This Agreement shall become effective on the 29th day of March, 2007 and shall terminate on the 28th day of March, 2008. This Agreement shall automatically renew for two (2) additional twelve (12) month periods upon the same terms and conditions herein set forth, unless written notice of non-renewal is given by either of the parties not later than thirty (30) days prior to March 28, 2009.

COUNTY and CONTRACTOR agree that this Amendment is sufficient to amend the Agreement and, that upon execution of this Amendment, the Agreement and this Amendment together shall be considered the Agreement.

The Agreement, as hereby amended, is ratified and continued. All provisions, terms, covenants, conditions and promises contained in the Agreement and not amended herein shall remain in full force and effect.
