1 SECOND AMENDMENT TO AGREEMENT

2 THIS SECOND AMENDMENT TO AGREEMENT (hereinafter "Amendment") is made
3 and entered into this 21st day of March, 2010, by and between COUNTY OF FRESNO, a
4 Political Subdivision of the State of California, Fresno, California (hereinafter "COUNTY"), and
5 the Law Firm of Campagne & Campagne whose address is 1685 N. Helm Avenue, Fresno,
6 CA 93727, hereinafter referred to as "CONTRACTOR".

7 WITNESSETH:

8 WHEREAS, COUNTY and CONTRACTOR entered into Agreement number 270173F,
9 dated 29th day of March, 2007 (hereinafter "Agreement"), pursuant to which CONTRACTOR
10 agreed to provide legal services for the Civil Service Commission to COUNTY; and

11 WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement in
12 order to extend the term of the agreement for six (6) additional months.

13 NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of
14 which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

15 1. First Amendment to Agreement Number 270173F, line sixteen (16) through line
16 twenty-two (22), is deleted in its entirety and replaced with the following:

17 "This Agreement shall become effective on the 29th day of March, 2007 and shall
18 terminate on the 28th day of September, 2010."

19 COUNTY and CONTRACTOR agree that this Amendment is sufficient to amend the
20 Agreement and, that upon execution of this Amendment, the Agreement and this Amendment
21 together shall be considered the Agreement.

22 The Agreement, as hereby amended, is ratified and continued. All provisions, terms,
23 covenants, conditions and promises contained in the Agreement and not amended herein
24 shall remain in full force and effect.
