- Q1. Is there currently a consultant for the plan?
- A1. The current consultant for the plan is Heintzberger-Payne Advisors.
- Q2. Based upon the RFP that was issued in 2011, it appears that the existing consulting contract with HPA has one additional optional year. Is there a reason this option has not been extended?
