Please provide your comments on the scope and content of the Draft Environmental Impact Report to be prepared for the Fresno County General Plan Update. You may submit comments by completing and returning this form at the scoping meeting, or sending written comments to the address provided below so that they are received no later than June 7, 1999.

Page-6, of "Draft EIR for the F.C. General Plan Update, Notice of Preparation" show City of San Joaquin's population in 1996 as 3,718 and in Year 2020 as 6,241. How did we get to these figures? What percentage of growth it represents? According to the State Dept. of Finance, S.J. population in 1996 was 4,924. The San Joaquin General Plan, on the other hand, projects city's population to reach 7,672 in the year 2020 at an annual growth rate of 4%. The state population figure and our records doesn't match with your figures. Is there something wrong? Please check the numbers to clear up our confusion.
