WHEREAS, on June 13, 1975, this Board authorized staff to engage in mediation regarding non-economic items where agreement had not yet been reached with employee groups. Since then agreement has been reached with most, though not all, groups; and

WHEREAS, the Administrative Officer is recommending implementation of Memoranda of Understandings with the following employee groups:

WHEREAS, the parties involved have agreed to the deletion of item No. 2 of the addendum to the memorandum of understanding with the Law Enforcement Employees Association; and

WHEREAS, the Administrative Officer reports that each of the memoranda contain sections which necessitate changes to the Salary Resolution and Administrative Code. Further changes will be

1 necessary in the near future to implement the annual leave plan
2 and unemployment compensation provisions thereof; and

3 WHEREAS, the County Administrative Officer has recommended
4 to this board, and this board hereby finds it to be in the best
5 interest of the County of Fresno and its employees, that net take
6 home pay of employees be increased without increasing county costs
7 over what the county would otherwise pay its employees in straight
8 salary; and that to accomplish the same this board should by reso-
9 lution implement Government Code Sections 31621.5 and 31639.5 and
10 make off-setting adjustments in salary of all classifications of
11 county employees as set forth in Attachments A and B hereto,
12 effective July 25, 1975, which adjustments are hereby found by this
13 board to reflect the cost to the county of implementing said pro-
14 visions of the Government Code;

15 NOW, THEREFORE, adopting the recommendations of the County
16 Administrative Officer, and on motion of Supervisor Donaldson,
17 seconded by Supervisor Ventura, and carried, IT IS ORDERED that
18 the above-listed memoranda of understanding should be and hereby is
19 implemented and the salary resolution is hereby amended as set forth
20 in Attachments A and B, effective July 25, 1975. Government Code
21 Sections 31621.5 and 31639.5 are implemented by separate resolution
22 of this board.

23 IT IS FURTHER ORDERED that the transfer of funds, in
24 amount of \$13,500.00 as agreed upon with the Prosecutors Association,
25 be approved.

NOW, THEREFORE, BE IT RESOLVED that the provisions of Sections 31681.2, 31681.4, 31739 and 31739.2 be, and they are hereby made applicable to the County of Fresno as provided therein, and that the applicability of such Sections to the County of Fresno be effective as of October 1, 1960.
